### SECTION 7: HANDLING AND STORAGE.

#### 7.1 Precautions for safe handling.

The fumes are heavier than air and can spread across the ground. They can form explosive mixtures with air. 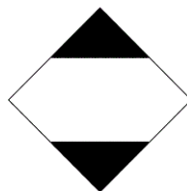
