SECTION 4: FIRST AID MEASURES.

4.1 Description of first aid measures.

SECTION 6: ACCIDENTAL RELEASE MEASURES.

6.1 Personal precautions, protective equipment and emergency procedures.

Eliminate possible ignition points and ventilate the area. No smoking. Avoid breathing fumes. For exposure control and individual protection measures, see section 8.

6.2 Environmental precautions.

7.1 Precautions for safe handling.

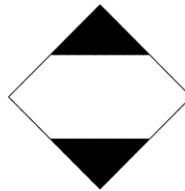
