4.3 Indication of any immediate medical attention and special treatment needed.

SECTION 5: FIREFIGHTING MEASURES.

5.1 Extinguishing media.

Recommended extinguishing methods.

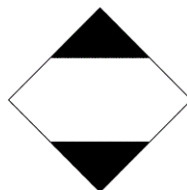
